

Proceeding of the Technical Evaluation Committee held on 26.2.2024 for
tender no. 273/ CDA dated 08.02.2024 "Tender for Selection of a
Service Provider firm for Engagement of Manpower in Chilika
Development Authority"

After approval of the Competent Authority, Tender for selection of a service provider for engagement of manpower in Chilika Development Authority was put to advertisement in two local dailies i.e. The Samaja and Prameya and also uploaded in the Chilika website www.chilika.com. The date for sale of the tender papers was 09.2.2024 by 10.30 AM. The last date for submission of the sealed tender papers was 23.2.2024 by 5.00 PM. The bids received within the stipulated time period were opened on 26.2.2024 at 11.00 AM as per the advertisement, in the presence of the authorized representatives of the bidders and the committee members. In total 16 (sixteen) bidders participated in the tender . The technical evaluation was carried out by the committee members thoroughly and the report is placed below.




