1. i) Registration Number - Chain mounted, Earth moving Excavator  
ii) Make, Model & type of vehicle - EX-200LC (Tata Hitachi), Backhoe earth moving Excavator  
iii) Year of purchase - Year 2003  
iv) Period of service rendered - 18 ½ years  
v) Kilometer run - 5860 Hours.
2. The intending tenderers are advised to inspect the excavator Tata Hiatachi EX-200 LC, kept in Chilika Development Authority premises at Ansupa, Cuttack on any of the working days (contact person Sri B.R.Mohanty, Jr. Engineer, Mob No.9437178796), preceding the last date of submission of tender. The tender should accompany an **Earnest Money Deposit (EMD)** of Rs.40,000.00 (Rupees forty thousand) only in shape of Bank Draft drawn in any Nationalized Bank in favour of Chief Executive, Chilika Development Authority and payable at Bhubaneswar. This will be refunded back to the unsuccessful bidders.
3. The tenders will be received in the Sealed Tender box placed at Reception of Chilika Development Authority, Plot No.493(P), Palaspalli, Bhubaneswar
4. The last date for submission of tender is 25.08.2022 by 2.00 P.M. and will be opened on the same day at 4.00 P.M. of Chilika Development Authority, Bhubaneswar in presence of the tenderers or their authorized agents.
5. The highest tenderer whose tender will be accepted shall have to deposit 25% of the offered amount within ten (10) days after the sale is confirmed and the rest amount within twenty (20) days from the date of confirmation of the tender. The successful tenderer shall remove the excavator (Tata Hitachi EX-200 LC) from Ansupa site of Chilika Development Authority within one month's from the date of depositing the full amount of the offered amount. In case he fails to deposit of the total amount as per its offer within the stipulated time, the deposits including earnest money shall be forfeited.

On failure to remove the excavator within the aforesaid time, the ground rent @ 2% of the offered amount shall be charged per each day or part of the day till removal of the excavator (Tata Hitachi EX-200 LC) from Ansupa site. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the excavator and the amount deposited by him shall be adjusted towards ground rent.
