The intending tenderers are advised to inspect the Crawl-Cat-1350 dredger (Kalijai-II) kept at Magarmukh site, Satpada, Puri on any of the working days (contact person Sri Biswajit Das, Jr. Engineer, Mob No.7008576007), preceding the last date of submission of tender. The tender should **accompany Earnest Money Deposit (EMD) of Rs.2,00,000.00 (Rupees two lakhs) only in shape of Bank Draft drawn in favour of Chief Executive, Chilika Development Authority and payable at Bhubaneswar.** This will be refunded back to the unsuccessful bidders.
3. The tenders will be received in Sealed Tender box at Chilika Development Authority, Plot No.493(P), Palaspalli, Bhubaneswar.
4. The **last date** for submission of tender is **10.11.2022 by 2.00 P.M.** and will be **opened** on the **same day at 4.00 P.M.** at Chilika Development Authority, Bhubaneswar in presence of the tenderers or their authorized representatives.
5. The highest tenderer whose tender will be accepted shall have to deposit **25% of the offered amount within 10 (ten) days** after the sale is confirmed and the **rest amount within next 15 (fifteen) days.** The successful tenderer shall **remove the Crawl cat-1350 dredger** from Magarmukh site of Chilika Development Authority **within one month** from the date of depositing the full offered amount.

In case he fails to deposit of the total amount as per it's offer within the stipulated time, the deposits including earnest money shall be forfeited. **On failure to remove** the dredger within the aforesaid time, the ground rent **@ 2% of the tendered amount** shall be charged **per each day** or part of the day till removal of the dredger from the site. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the dredger and the amount deposited by him shall be adjusted towards ground rent.
