CORRIGENDUM TO TENDER CALL NOTICE NO-1753 DATED 06.10.2023

The tender called vide notice no. 1753 dated 06.10.2023 is hereby modified as follows.

1. The bidders should have a valid license under PSARA (Private Security Agencies Regulation Act, 2005) to be submitted along with the technical proposal.
2. The bidders should submit an EMD of Rs. 50000/- (Rupees fifty thousand only) in shape of Demand Draft drawn in favour of the Chief Executive, Chilika Development Authority payable at Bhubaneswar from any Nationalized or scheduled bank.
3. The rate of service charge fixed by the Finance Department, Government of Odisha in the OM no. 19595/F dated 11.7.2023 (Annexure-F) shall be followed strictly. However the final quoted price should be in whole numbers. For example if the price arrived is Rs. 150.40 or below Rs. 0.50 paise it should be rounded up to 150.00 and if the price arrived is Rs. 150.50 or above Rs. 0.50 paise it should be rounded up to Rs. 151.00. The calculation of wage must be done on a monthly basis.
4. The tender document will be available in www.chilika.com from 9.10.2023 by 10.30 AM up to **14th November 2023, 4.00 PM.**
5. The last date for submission of the tender document is extended up to **14th November 2023 by 4.00 PM.**
6. The date of opening of sealed tender will be on **15th November 2023 at 11.00 AM in the Office of the Chief Executive, Chilika Development Authority, 493(P), Pallaspalli, Pokhariput road, BBSR-20.**

All other terms and conditions as mentioned in the tender document no. 1753 dated 6.10.2023 shall remain unchanged.

Sub.: Rate of Service Charge in Outsourcing of Services.....reg.

As no minimum rate of service charge has been prescribed, bidders are quoting zero or negligible service charge in respect of outsourcing of services. Hence, many a time, references are being received from various quarters for clarification in this matter.

2. In the meantime, Department of Expenditure, Ministry of Finance, Government of India has fixed the minimum rate of services charge vide OM No F.6/1/2023-PPD dated 06.01.2023.

3. Now, the State Government has been pleased to fix the following rate of service charge in outsourcing of services:


a. The minimum service charge shall be 3.85% (3% profit plus transaction charge);

b. The procuring entity can also fix the service charge above 3.85% with proper justification, whenever required. However, such charge should not exceed 7% in any case.

4. These instructions shall be deemed to be part of Odisha General Financial Rules.

This shall be effective from the date of issue.
